U UNCLEANLINESS IS NOT PERMITTED
L LEAVE OTHER'S PROPERTY ALONE
E EXCEPT WHEN SLEEPING, WEAR SHOES
S SCRAPE YOUR PLATE AT MEAL TIMES

R RETRIEVE ANY OF YOUR BELONGINGS
U UNLEASH YOUR GOOD ATTITUDE
L LISTEN TO CAMP STAFF
E EXCLUDE YOURSELF FROM ANY P.D.A.
S *SUPPRESS BAD LANGUAGE*

In addition to these rules you should know of a few other expectations. You will be expected to eat at all meals, go to sleep when asked, dress modestly, and obey the instructions of your counselors and directors.

We do allow students to carry their **cell phones** but ask they not be used to make outgoing calls or text unless it is an emergency. We do not allow headphones in ears at any time. Should phones become a distraction we will confiscate them and contact the parents / guardians.

Also, The Camp has asked we make you aware of some general camp rules.

GENERAL CAMP RULES

- WE ARE A RESIDENTIAL NEIGHBORHOOD, ALL CARE SHOULD BE TAKEN TO NOT BOTHER THE NEIGHBORS, NOR INFRINGE ON THEIR PRIVACY OR PROPERTY. **SORRY, NO PETS.**

- NO ONE SHOULD BE OUT PLAYING OR MAKING NOISE **BEFORE 8 AM OR AFTER 10 PM.**

- THE CHAPEL SOUND SYSTEM SHOULD NOT BE TURNED ON BEFORE 8 AM AS WELL AS ANY MUSICAL INSTRUMENTS, RADIOS, ETC. AT 10 PM ALL SOUND EQUIPMENT MUST BE TURNED DOWN OR OFF.
 - ☞ THE CAMP MANAGER WILL MAKE SURE THIS RULE IS FOLLOWED AND RESERVES THE RIGHT TO LOWER THE SOUND VOLUME DURING THE SERVICES SHOULD IT BE CONSIDERED TOO LOUD.

- ANY FELLOWSHIPING OUTSIDE OF THE CHAPEL AFTER 10 PM MUST BE CONFINED TO THE DINING HALL WITH THE DOORS AND WINDOWS CLOSED.

- **THIS IS A CHRISTIAN CAMPGROUND. NO SMOKING, DRINKING OF ALCOHOLIC BEVERAGES, MARIJUANA, NOR ANY ILLEGAL DRUG USE WILL BE PERMITTED. ANYONE BREAKING THIS RULE WILL BE ASKED TO LEAVE THE CAMPGROUND.**

- THE CHAPEL IS NOT TO BE USED AS A PLAY AREA. EATING AND DRINKING ARE NOT ALLOWED IN THE CHAPEL.

- ROCK MOVING AND STONE THROWING IS PROHIBITED AS WELL AS THROWING OF SNOWBALLS AT ANY BUILDING.

- SPORTS EQUIPMENT WILL BE GIVEN TO THE “GROUP DIRECTOR” AND HE/SHE WILL BE RESPONSIBLE TO RETURN IT TO THE CAMP MANAGER PRIOR TO LEAVING. ANY BROKEN OR LOST ARTICLES WILL BE CHARGED TO THE GROUP.
